

**FACTORS RELATED TO THE LOW COVERAGE OF K1 PREGNANT WOMEN AT THE BETUN COMMUNITY HEALTH CENTER, CENTRAL MALACCA DISTRICT, MALAKA REGENCY, EAST NUSA TENGGARA PROVINCE**

**ABSTRACT**

**Background:** Assessment of the implementation of health services for pregnant women can be done by looking at the coverage of K1. Indonesia's health profile data in 2020 which checks pregnancy at K1 visits or early visits in the 1st trimester at 0-12 weeks of gestation with a percentage of 93.3%. Meanwhile, for the Province of East Nusa Tenggara, which checked for pregnancy in the early trimester or K1, the percentage was 68.6%. This incident is very far from the national target of 95%.

**Objective:** To determine the factors related to the low visit of pregnant women K1 at the Betun Health Center, Central Malacca District, Malacca Regency, East Nusa Tenggara Province.

**Methods:** This research is an observational, descriptive type using a cross sectional approach. This research was conducted in March - April 2022. The study population was pregnant women at the Betun Health Center, Central Malacca District. The sample is 63 pregnant women. Data analysis using Chi square.

**Results:** Most of the respondents in this study were of no risk age (81.6%), graduated from junior high school/high school (60.5%). Not working (71.1%) and multigravida parity (60.5%) Chi-square analysis shows that there is a significant relationship between service coverage including service distance and transportation with low visits by pregnant women K1 at Puskesams Betun, Central Malacca District with a p-value value 0.013. there is a significant relationship between family economic income and the low visitation of pregnant women K1 at Puskesams Betun, Malacca District, the middle p-value is 0.001. there is a significant relationship between place of residence and the low visitation of pregnant women K1 at Puskesams Betun, Malacca District, middle p-value 0.004.

**Conclusion:** There is a relationship between service coverage, economic income and place of residence with low visits by pregnant women K1 at Puskesams Betun, Central Malacca District.

**Latar Belakang:** Penilaian terhadap pelaksanaan pelayanan kesehatan ibu hamil dapat dilakukan dengan melihat cakupan K1. Data profil kesehatan Indonesia tahun 2020 yang memeriksakan kehamilan pada kunjungan K1 atau kunjungan awal pada trimester 1 di usia kehamilan 0-12 minggu dengan persentase 93,3%. sementara untuk Provinsi Nusa Tenggara Timur yang memeriksakan kehamilan pada trimester awal atau K1, sehingga persentasenya menjadi 68,6%. Kejadian ini sangat jauh dari target nasional yaitu 95%.

**Tujuan:** Mengetahui faktor-faktor yang berhubungan dengan rendahnya cakupan kunjungan ibu hamil k1 di Puskesmas Betun Kecamatan Malaka Tengah, Kabupaten Malaka, Provinsi Nusa Tenggara Timur.

**Metode:** Penelitian ini adalah *Observasional*, jenis *deskriptif* dengan menggunakan pendekatan *cross sectional*. Penelitian ini dilaksanakan pada bulan Maret - April 2022. Populasi study penelitian ini adalah ibu hamil di Puskesmas Betun kecamatan Malaka Tengah.dengan jumlah sampel 63 Ibu hamil. Analisis data menggunakan uji *Chi square*.

**Hasil:** Karakteristik responden pada penelitian ini sebagian besar memiliki usia yang tidak beresiko (81,6%), pendidikan lulus SMP/SMA (60,5%). Tidak bekerja (71,1%) dan paritas multigravida (60,5%) Analisis *chi-square* menunjukan bahwa ada hubungan bermakna antara jangkauan pelayanan dengan nilai *p-value* 0,013. Ada hubungan bermakna antara pendapatan ekonomi nilai *p-value* 0,001. Ada hubungan bermakna antara tempat tinggal dengan nilai *p-value* 0,004.

**Kesimpulan:** Ada hubungan bermakna antara jangkauan pelayanan, pendapatan ekonomi dan tempat tinggal dengan rendahnya kunjungan ibu hamil K1 di Puskesams Betun Kecamatan Malaka Tengah.
