



Letter of Agreement and all its annexes (hereinafter referred to as "Contracts") were made and signed electronically on the day of **Monday** date **21** (*Twenty one*) month **March** year **Two thousand twenty two**, between:

1. **Teguh Handoko, SKM** :As a Director acting for and on behalf of PT. Multi Area Desentralisasi Pembangunan (MADEP), Domiciled in Jakarta in this case further acts for and on behalf of Consultant implementing the activity, to be further called the **FIRST PARTY**.
2. **Siti Rochmah**: As Member of Provincial Research Team Yogyakarta, Domiciled in the Province of Yogyakarta in this case further acts for and on behalf of **PROVINCIAL RESEARCH TEAM DI YOGYAKARTA**, to be further called the **SECOND PARTY**.

The PARTIES explained in advance that:

- (a) A team selection process has been held in accordance with the Proposal Guidelines.
- (b) The **FIRST PARTY** and the **SECOND PARTY** shall express the authority to sign this Contract and bind the represented party.
- (c) Contract Signing Officers and Providers acknowledge and represent that in connection with the signing of this Contract each party:

THEREFORE, THE FIRST PARTY and THE SECOND PARTY to bind themselves in an Assignment of Research Grant Agreement which is a cooperation of the Asian Development Bank (ADB) and the Ministry of Health in the framework of "Trend, Multilevel Analysis Determinan Stunting Children Before And During Covid-19 Pandemic And Nutrition Mentoring Intervention For Stunting Children In Yogyakarta", with the provisions and conditions stipulated in the articles as next:

MAKA OLEH KARENA ITU, PIHAK PERTAMA dan PIHAK KEDUA secara bersama-sama bersepakat mengikatkan diri dalam suatu Perjanjian Penugasan Pelaksanaan Penelitian Hibah (Research Grant) yang merupakan kerjasama Asian Development Bank (ADB) dan Kementerian Kesehatan RI dalam rangka "Trend, Analisis Multilevel Determinan Stunting Sebelum Dan Selama Pandemi Covid-19 Serta Intervensi Pendampingan Balita Stunting Di Yogyakarta" dengan ketentuan dan syarat-syarat yang diatur dalam pasal-pasal sebagai berikut:

Article 1 Research Title

- (1) The **FIRST PARTY** assigns the task to the **SECOND PARTY**, upon the selection of the **SECOND PARTY** as one of the recipients of research grants from the Asian Development Bank (ADB) based on the Decision Letter on the Results of the Research Proposal Assessment Selection Number: KS.02.01/2/920/2022, dated **February 21, 2022** which was signed by the Secretary of the Health Development Policy Agency (BKPK), the Indonesian Ministry of Health.
- (2) The Research that will be carried out by the **SECOND PARTY** is entitled:

"Trends and Multilevel Determinants of Stunting Before and During The Covid-19 Pandemic, and Interventions for Stunting Reduction Acceleration In Yogyakarta"

Article 2 Contract Value

The **FIRST PARTY** provides research grant funds as referred in Article 1 is **USD 30,000 (Thirty thousand US Dollars)** based on the **FIRST PARTY** Contract with the Asian Development Bank (ADB).

Article 3 Payment Methods

Pasal 1 Gambaran Umum

Pasal 2 Nilai Kontrak

PIHAK PERTAMA memberikan dana hibah penelitian sebagaimana dimaksud pada Pasal 1 adalah sebesar **USD 30.000 (Tiga puluh ribu US Dollar)** sesuai dengan Kontrak **PIHAK PERTAMA** dengan Asian Development Bank (ADB).

Pasal 3 Cara Pembayaran

- (1) Payment of Research Grant Funds is carried out in stages after the output and other requirements are approved/validated by **FIRST PARTY** and **SECOND PARTY** and will receive USD 30,000 (Thirty thousand US Dollars);
- (2) Payment of research grant funds will be paid in stages to a **SECOND PARTY** account under the following conditions:
 - a) The First Phase payment is 20% of the total research grant that is $20\% \times \text{USD } 30,000 = \text{USD } 6,000$ (Six thousand US Dollars) after the letter of agreement on implementation of this research grant was signed by both parties and the **SECOND PARTY** submitted revised research proposal, revised research work plan and the plan for use of grant funds. Evidence of submission of work results is stated in the Minutes of Handover of Work Results;
 - b) Second Phase Payment is 30% of the total research grant that is $30\% \times \text{USD } 30,000 = \text{USD } 9,000$ (Nine thousand US Dollars) is paid after the **SECOND PARTY** submitted a softcopy of Progress Report on the Implementation of Research Grant Assignment and Accountability Report on the Use of Research Grants Budget of 20% (Term 1) that has been implemented to the **FIRST PARTY**. Evidence of submission of work results is stated in the Minutes of Handover of Work Results;
 - c) Third or Final Phase is 50% of the total research grant that is $50\% \times \text{USD } 30,000 = \text{USD } 15,000$ (Fifteen thousand US Dollars) is paid after the **SECOND PARTY** submitted a softcopy of the Final Report on the Implementation of Research Grant Assignments, Carrying out Regional and National Dissemination, deliver policy briefs and Manuscripts along with evidence of their submission to national / international journals, as well as Accountability Report on the Use of Research Grants Budget of 30% (Term 2) and 50% (Term 3) that has been implemented to the **FIRST PARTY**.
 - d) The **SECOND PARTY** is responsible for the expenditure of such funds in paragraph (1) in accordance with Approved Research Proposal and Work Plan and is obliged to submit all evidence of expenditure in

 - f) The Financial Administrator can be appointed from team members or from outside the team with the allocation of honorarium/ incentives issued from research grant funds.
- (3) Payment currency: Rupiah which will be converted according to the **FIRST PARTY** Bank Rate.
- (4) All bank administration arising from above payment transactions shall be borne by the **SECOND PARTY**.

Article 4 Payment Transfer

- (3) The **FIRST PARTY** does not provide bailout funds, in the event of a delay in disbursement from the ASIAN DEVELOPMENT BANK (ADB).
- (4) The **FIRST PARTY** shall not be responsible for delays and/ or unpaid amounts of funds as referred to in article 3 paragraph (1) caused by the error of the **SECOND PARTY** in submitting the report and data of the researcher, bank name, account number, and other requirements that

- (5) The **FIRST PARTY** organizes and facilitates:
 - a) Research Dissemination activities at the regional level in the framework of policy brief socialization to local governments by online.
 - b) Monitoring and Evaluation (Monev) Consulting team (Research Grant Coordinator) **FIRST PARTY** towards the progress of the implementation of Research Grant Program Year 2022 was carried out 3 (three) times in the form of FGD progress of online research results (Zoom Meeting) according to the schedule that has been set.
 - c) **FIRST PARTY** will appoint a person in charge of Monitoring and Evaluation (MONEV) who will accompany the research team.

Article 5 Rights and Obligations

- (1) The **SECOND PARTY** is obliged to follow up and seek the results of research undertaken to obtain patents and/ or public for the title of Research as referred to in Article 1.
- (2) The **SECOND PARTY** is obliged to report the development of acquisition of patents and/ or scientific publications as referred to in paragraph (1) periodically to the **FIRST PARTY**.
- (3) The **SECOND PARTY** is obliged to:
 - a) Produce a Policy Brief that is socialized to local governments;
 - b) Publications (scientific, popular, booklets, leaflets, others);
 - c) Produce manuscripts that have been sent to national and international journals;
 - d) Record all program implementation activities in the Research Notebook (logbook), make a report on the progress of research, make a complete budget usage report after the letter of agreement on implementation of research grant is signed up to no later than **August 17, 2022**.
 - e) Send all report obligations by email: adb.madep@gmail.com as scheduled and final report no later than **17 August 2022** to the **FIRST PARTY**;
 - f) Participate in Monev activities, Regional

- (2) **PIHAK KEDUA** berkewajiban untuk melaporkan perkembangan perolehan paten dan/ atau publikasi ilmiah seperti yang dimaksud pada ayat (1) secara berkala kepada **PIHAK PERTAMA**.
- (3) **PIHAK KEDUA** berkewajiban untuk:

 - b) Publikasi (ilmiah, populer, booklet, leaflet, lainnya);
 - c) Menghasilkan Manuscript yang sudah dikirim ke jurnal nasional dan internasional;

Article 6
Card Validity Period

- (1) The validity of the contract is from the date of signing the implementation agreement until **August 17, 2022**.
- (2) If the **SECOND PARTY** does not submit its research report until the deadline set on this contract at the end of the current budget year and the deadline for disbursement of cost has expired, then all costs concerned that have not been disbursed, declared forfeited (cannot be disbursed);
- (3) Negligence that causes the incompleteness of research that the external promise in the research proposal as referred to in Article 4 is not fulfilled becomes the responsibility of the **SECOND PARTY**.

Article 7

- (1) The **SECOND PARTY** is obliged to ensure that the research under the title as referred to in article 1 is not plagiarism or duplication of research. If it turns out that the research conducted is plagiarism or duplication of research, then the **SECOND PARTY** is willing to cancel its research and the **SECOND PARTY** obliged to return all funds received to the **FIRST PARTY** Account;
- (2) If the **SECOND PARTY** is unable to carry out the duties referred to in Article 1 then it shall return the funds that have been received to the **FIRST PARTY** Account.

Article 8
Report

- (1) The **SECOND PARTY** must submit a softcopy of all reports and research results output via email that has been established.
- (2) The report of research result in the form of

Pasal 6
Masa Berlaku Kontrak

Sanksi




