ABSTRAK

Latar Belakang: Data kunjungan pemeriksaan ANC pada ibu hamil Puskesmas Banguntapan II mengalami penurunan drastis yaitu setiap harinya sebelum pandemi sebanyak 40 ibu hamil namun setelah pandemi hanya 10 sampai 20 ibu hamil, bahkan banyak ibu yang tetap tidak berkunjung walau sudah dijadwalkan untuk kunjungan. Banyak laporan dari kader desa setempat yang melaporkan data ibu hamil baru namun tidak melakukan kunjungan karena kondisi dan situasi pandemi. Penelitian ini untuk mengetahui faktor-faktor yang mempengaruhi kepatuhan kunjungan ANC pada ibu hamil pada era new normal. Penelitian observasional analitik dengan desain *case control* menggunakan data sekunder dari rekam medis dari Bulan Maret-November 2020. Subjek penelitian ini 104 ibu hamil di Puskesmas Banguntapan II dengan teknik *purposive random sampling*. Analisis data menggunakan uji *chi-square* dilanjutkan dengan regresi logistik.

Tujuan Penelitian: Mengetahui faktor-faktor yang mempengaruhi kepatuhan kunjungan ANC pada era new normal di Puskesmas Banguntapan II tahun 2020.

Metode Penelitian: Jenis penelitian ini adalah dengan desain penelitian case control, penelitian ini dilaksanakan pada bulan november 2020. Populasi penelitian ini adalah semua ibu hamil di wilayah kerja Puskesmas Banguntapan II sebanyak 300 ibu hamil, tehnik pengambilan sample dengan *purposive random sampling* jumlah sampel sebanyak 104. Instrument penelitian menggunakan data dari RM dan Kohort. Analisis data menggunakan *Chi Square*.

ABSTRACT

Background: *The ANC examination visit data for pregnant women at the Banguntapan II Community Health Center experienced a drastic decline, namely that every day before the pandemic there were as many as 40 pregnant women but after the pandemic only 10 to 20 pregnant women, even many mothers still did not visit even though they were scheduled for visits. Many reports from local village cadres that reported data on new pregnant women but did not visit due to pandemic conditions and situations. This study was to determine the factors that affect compliance with ANC visits to pregnant women in the new normal era. Analytical observational study with a case control design using secondary data from medical records from March-November 2020. The subjects of this study were 104 pregnant women at Banguntapan II Public Health Center using purposive random sampling technique. Data analysis used the chi-square test followed by logistic regression.*

Objective: *Knowing the factors that affect compliance with ANC visits in the new normal era at Banguntapan II Health Center in 2020*

Research Methods: *This type of research is an with case control , this study was conducted in november 2020 . The population of this study were all pregnant women in the working area of Banguntapan II Public Health Center as much as 300 pregnant women, the sampling technique with a purposive random sampling as much as 104. The research instruments used medical record and cohort . Data analysis using Chi Square.*
