

ABSTRACT

Diphtheria is a contagion deadly disease caused by Corynebacterium diphtheria which case increases every year in Blitar since 2011 until 2016. The purpose of this research is to know the correlation between house physical environment and diphtheria in Blitar in 2016. The method used was observational analytic study by using case control design. Samples in case group were 30 people of diphtheria patients and 59 people of control group which were not diphtheria patients. Physical environment of house was the independent variable while the dependent variable was diphtheria patients. 2016. Data were analysed by Chi Square. The results showed p value was 0.772 which means that there was no correlation associated with diphtheria. Further research should be conducted with more appropriate study design and observation in order to see the better result of the effect of house physical environment.
